PREHEARING OFFICER ORDER SETTING PREHEARING CONFERENCE

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

1. On January 3, 2019, the Commission issued a *Penalty Order* against Seymour Oil Co., Inc. (Operator) for one violation of K.A.R. 82-3-407 because a current and successful mechanical integrity test had not been performed on the subject well.¹
2. On January 28, 2019, Operator requested a hearing.² On March 21, 2019, the Commission issued an order setting an April 5, 2019, prehearing conference.³
3. At the April 5, 2019, prehearing conference, the parties agreed to set a new prehearing conference for April 22, 2019, with the anticipation that in the interim parties would discuss the possibility of settlement, and that Operator would obtain counsel if necessary.
