Dear Executive Director:

Jayhawk Pipeline, L.L.C. ("Jayhawk") is making this filing to cease operation of a segment of its common carrier pipeline and delete an origination from its Certificate of Convenience and Necessity. Please accept for approval the attached Application to Cease Operation (the "Application") of its pipeline from Taloga Station to Liberal Station in Morton, Stevens, and Seward Counties effective August 31, 2025. The facts presented in the Application substantiate the need to cancel the Taloga origination and discontinue operation of the referenced pipeline segment. As of this filing, a docket number has not been assigned to the following KCC Tariffs, submitted May 30, 2025, that had an effective date of July 1, 2025.

- I, Gregory L. Brown, of lawful age, being duly sworn upon oath, state as follows:
 - 1. I am Manager of Jayhawk Pipeline, L.L.C. ("Jayhawk").
 - 2. This Affidavit is being provided in support of the Application filed by Jayhawk in this docket seeking approval to abandon and terminate service on a 50-mile segment of pipeline from Taloga (Morton County) to Liberal (Seward County), Kansas (See Exhibit A).
 - 3. As a result of the abandonment, Jayhawk also seeks approval to delete originations from Taloga Station, Morton County, Kansas on KCC No. 80 Supplement 26 and Morton and Stevens Counties on KCC No. 83 Supplement 21.
 - 4. While performing integrity testing of its pipeline system with an inline inspection tool, Jayhawk identified numerous anomalies in the Taloga to Liberal segment that required significant repair in the immediate future. The estimated costs of making the necessary repairs to the segment, and corresponding risks to the environment, are too great to justify making those repairs. As such, Jayhawk is required to discontinue service on this line by August 31, 2025.
 - 5. Of note, discontinuing service at this time avoids repairs along the pipeline that could affect several high consequence areas, including potential drinking water sources.
 - 6. Shippers transporting crude oil on the Taloga to Liberal segment have destinations of Harper Ranch Station and McPherson, KS. Alternative pipeline options in proximity that support continued shipments include origination at Eubanks Station or Liberal Station on Jayhawk Pipeline, L.L.C.

7. If approved, the cessation of operations on the Taloga to Liberal segment will be effective August 31, 2025.


