**MOTION TO TERMINATE COMPLIANCE AGREEMENT**

Commission Staff moves for the Commission to terminate the Compliance Agreement between Commission District #3 Staff and W4 Energy (Operator) in this docket contingent upon the Commission granting Staff's motion to approve compliance agreement which is simultaneously filed in Docket 22-CONS-3471-CMSC (Docket 22-3471).

In May 2022, Operator filed Request for Change of Operator Transfer of Injection or Surface Pit Permit (T-1) Forms to transfer each of the wells remaining on its license to TexxStar, Inc., License No. 35941. At the time the T-1s were filed, 93 wells remained on Operator's Compliance Agreement. Commission Staff negotiated an updated compliance agreement with TexxStar, Inc. which is attached to the motion to approve compliance agreement that is being simultaneously filed in Docket 22-3471. That agreement addresses the remaining 93 wells out of compliance with K.A.R. 82-3-111. Upon approval of both motions, Staff will process the T-1s filed transferring Operator's wells to TexxStar, Inc. Since the remaining wells will be addressed in that agreement, Staff believes it is appropriate for the Compliance Agreement in this docket to be terminated by the Commission.
