SUSPENSION ORDER

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the pleadings and record, the Commission makes the following findings:

1. On December 9, 2013, Kansas City Power & Light Company (KCP&L) filed its Application for an abbreviated rate case to include costs associated with construction of environmental upgrades at the La Cygne Generating Station in its rates, update its costs to reflect the completion of certain components of the La Cygne Environmental Project and construction work in progress, and incorporate updates to certain regulatory amortizations into KCP&L's rates.¹
2. The Commission has jurisdiction over this proceeding pursuant to K.S.A. 66-117.
3. A full investigation of the Application, which may result in a hearing, is deemed necessary and proper. The Commission finds and concludes that suspension of the Application and deferral of its effective date are required to allow sufficient time for full investigation of this matter. The Application should be suspended for a period of 240 days from the date it was filed, December 9, 2013, until Wednesday, August 6, 2014, pursuant to K.S.A. 66-117(c).

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. The Application is suspended for a period of 240 days from the date it was filed until August 6, 2014.


B. The parties have 15 days from the date this Order was served to petition for reconsideration.²

C. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it deems necessary.


