PETITION TO INTERVENE

COMES NOW these petitioners and by and through their attorney, Gerald O. Schultz, and hereby requests that the following ratepayers be permitted to intervene in the above matter under the authority of K.S.A. 82-1-225. The petitioners are:

- A. Woodford-O'Brate, Inc., (hereinafter referred to as "WOB") a Kansas family farm corporation, with its corporate office in Garden City, Kansas in which Cecil O'Brate is the principal owner thereof.
- B. Palmer Mfg. & Tank, Inc., (hereinafter referred to as "Palmer) a Kansas corporation engaged in the business of commercial tank manufacturing with its principal place of business in Garden City, Kansas in which Cecil O'Brate is the President and principal owner thereof.
- C. American Warrior, Inc., (hereinafter referred to as AWI) a Kansas corporation engaged in the business of oil and gas exploration, production and ownership of oil and gas properties with its corporate office in Garden City, Kansas in which Cecil O'Brate is the President and principal owner thereof.

In support of this petition, petitioners state the following:

1. On March 2, 2009 Wheatland Electric Cooperative, Inc. (hereinafter referred to as "Wheatland" filed an Application for approval of rate changes for electric service.

- 2. Petitioners, described in Paragraphs A,B. & C above, are each in good standing with the State of Kansas, are each rate payers adversely effected by the proposed rate changes which will diminish each company's ability to be competitive in the current economic recession.
- A copy of each company's applicable electric statements are attached as Exhibits A,
 B & C respectively. The proposed change in rates would dramatically effect economic viability of each Petitioner herein.
- 4. The proposed changes in rate, as set forth in the application, if approved, would significantly increase each petitioners cost of electricity in a manner which would adversely affect WOB's ability to produce crops at current prices, Palmer's ability to utilize commercial electricity further narrowing a narrow margin of profitability as a major employer in the manufacturing sector, and AWI's ability to produce marginal wells within the market area of the application, resulting in loss of valuation, loss of jobs and waste along with loss of much needed economic vitality which is so very crucial for this region of Kansas, particularly during this economic recession.
- 5. The Commission shall grant a petition to intervene when the petitioner has demonstrated that its legal rights, duties, privileges or other legal interests may be substantially affected by the proceeding, as set forth in K.A.R. 82-1-225(2), that the petition is timely, and that the proceedings will not be impaired by allowing the intervention. Petitioner states that by permitting the intervention, the Commission will allow a diversity of ratepayers to be heard regarding the Wheatland application and that none of the applicants will duplicate or delay the proceedings.

6. WOB, Palmer and AWI request that each be permitted to intervene and that their counsel, Gerald O. Schultz be added to the service list for all pleadings, communication and/or correspondence:




