
Dear Ms. Retz,

We are enclosing the FCC Section 254(e) certification form for Federal Universal Service Support in the above referenced docket for Mutual Telephone Company.

We are filing the Rate Floor Data, along with Attachments 2a and 4 proprietary and confidential under seal. Mutual Telephone Company believes that the information contained in the Rate Floor Data, Attachment 2a, and Attachment 4 is of such competitive sensitivity that its disclosure to any person other than Mutual, the Commission, and Staff is prohibited by K.S.A. 66-1220(a). Disclosure of trade secrets and confidential information to any person, including parties to this proceeding, is prohibited unless the Commission finds the disclosure is warranted, after considering all of the factors in that statute. The carrier believes that disclosure of the information contained in the Rate Floor Data, Attachment 2a, and Attachment 4 would have a significant and adverse impact on its competitive stance regarding existing or potential competing entities including wireless carriers, competitive local exchange carriers, and incumbent local exchange carriers. Regulatorily mandated disclosure of any or all of the subject information would create a competitive bias in favor of any actual or potential competitor not required to provide comparable information, reducing or eliminating any benefit to consumers otherwise resulting from unbiased competition and damaging the submitting company's ability to engage in fair competition.


