**JOINT MOTION**

Sunflower Electric Power Corporation (“Sunflower”), Kansas Electric Power Cooperative, Inc. (“KEPCo”) and the Staff of the Kansas Corporation Commission of the State of Kansas (“Staff”)(collectively, Sunflower, KEPCo, and Staff are hereinafter referred to as the “Joint Movants”) hereby file this Joint Motion respectfully requesting the Kansas Corporation Commission of the State of Kansas (“Commission”) to transfer all pleadings and documents of record in this proceeding to Docket No. 06-SEPE-1203-CON. In support of its Joint Motion, Joint Movants state as follows:

1. On May 12, 2006, Sunflower and KEPCo filed a joint application in Docket No. 06-SEPE-1203-CON (the “06-1203 Docket”) for Commission approval of a Wholesale Power Agreement (“WPA”), dated May 11, 2006, between Sunflower and KEPCo. The WPA provided that Sunflower would sell and KEPCo would purchase power and energy from Sunflower at Sunflower’s Member Rate (“WHM Rate”) under tariff schedule WHM-04 plus an adder (collectively, the “WPA Rate”). The Commission approved the WPA and WPA Rate on July 17, 2006 in the 06-1203 Docket.

2. Since December 16, 2011, Sunflower’s Board of Directors has annually modified its WHM Rate resulting in Sunflower filing an application in the 06-1203 Docket each year, in accordance with the April 19, 2010 Order Approving Stipulation and Agreement in the 06-1203 Docket, to reflect the revised WPA Rate and request its approval.

3. On November 2, 2018, Sunflower filed an application requesting approval of WHM-19 as the contract rate for the WPA. That filing was docketed as a new docket and assigned Docket No. 19-SEPE-185-CON.

4. For ease of administration, and to remain consistent with the historical filings regarding the WPA and its updated rate schedule each year, Joint Movants respectfully request that all pleadings and documents of record in Docket No. 19-SEPE-185-CON be transferred to the 06-1203 Docket, and Docket No. 19-SEPE-185-CON be subsequently closed.

5. As part of the transfer between dockets, Joint Movants recognize the previously issued Orders in the 19-SEPE-185-CON Docket shall remain intact and enforceable in the 06-1203 Docket.

6. Furthermore, Docket No. 06-SEPE-1203-CON is currently closed and will need to be reopened to allow for pleadings and orders to be subsequently filed. Joint Movants agree that Docket 06-1203 should remain open until a final order is issued by the Commission.

WHEREFORE, for the reasons set forth above, Joint Movants respectfully request this Joint Motion be granted, and for any other relief the Commission deems just and reasonable.


