- Residential access line rate will increase by \$1.50 (Current access line rate is \$18.00 increasing to \$19.50)
- Home Phone Standard Service Package will increase by \$2.50
- Voice Advantage and Voice Advantage II bundles will increase by \$2.50 (residential access line rate increase of \$1.50 and intrastate long distance minutes' rate increase of \$1.00)

A copy of the bill messaging that will be used to notify customers of these changes is enclosed for your reference. These bill messages will be delivered to customers as part of the March 16, 2022, billing cycle.
