NOTICE OF FILING

Kansas City Power & Light Company ("KCP&L") hereby submits this Notice of Filing informing the State Corporation Commission of the State of Kansas ("Commission") that the most recent quarterly report on quality assurance performance metrics for first quarter 2012 ("Report") required to be filed pursuant to the Commission's September 17, 2008 Order (the "Order"), was timely filed on April 30, 2012 in this Docket No. 12-KCPE-791-CPL (the "791 Docket"). This Notice also notifies the Commission that all future quarterly quality assurance performance metric reports will be filed in the 791 Docket.


In the Order, the Commission closed Docket No. 07-KCPE-1064-ACQ (the "1064 Docket") and directed the opening of a sub-docket 07-KCPE-1064-ACQ-CPL-1 under which these quarterly compliance filings were to be made.¹ Due to system changes at the Commission, sub-dockets were never opened and the Commission now uses separate compliance ("CPL") dockets for reporting purposes. Therefore, consistent with this new Commission process, KCP&L initiated the opening of a separate compliance ("CPL") docket, the 791 Docket, to serve as the compliance repository for the quarterly quality assurance performance metrics reports on a forward-going basis beginning with this first quarter 2012 report. All quarterly report compliance filings prior to this Report were made under the original Docket No. 07-

KCPE-1064-ACQ with a heading showing the CPL-1 sub-docket. All quality assurance performance metrics reports for 2012 and beyond will be filed under this new CPL docket with a heading that ties back to the 1064 Docket. Notice is being filed both in this 791 Docket and in the 1064 Docket reflecting the change in filing location.
