PREHEARING OFFICER'S ORDER SETTING PROCEDURAL SCHEDULE

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. The Commission has designated Brian Fedotin, Advisory Counsel, to act as Prehearing Officer in this proceeding. Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

- 1. On December 12, 2012, Black Hills/Kansas Gas Utility Company, LLC, d/b/a Black Hills Energy (Black Hills) filed an application for approval of a new Gas System Reliability Surcharge.
 - 2. On January 18, 2013, the parties filed a Joint Motion for Procedural Schedule.
- 3. Finding the agreed upon proposed schedule to be reasonable, the Commission adopts the following:

A prehearing conference is necessary prior to an evidentiary hearing to address any pending matters, to establish procedures for the evidentiary hearing, and to consider any other prehearing issues, which may promote the orderly and prompt conduct of this proceeding. K.S.A. 77-517; K.A.R. 82-1-222. Accordingly, the Prehearing Conference is set for March 8, 2013, beginning at 10:00 a.m. in the Commission's First Floor Hearing Room, 1500 SW Arrowhead Road, Topeka, Kansas 66604-4027. Prehearing Officer Brian G. Fedotin, telephone (785) 271-3105, email address <u>b.fedotin@kcc.ks.gov</u>, will preside. Any party who fails to attend or participate in the Prehearing Conference or in any other stage of this proceeding may be held in default under the Kansas Administrative Procedure Act (KAPA). K.S.A. 77-516(c)(8); K.S.A. 77-520. At the Prehearing Conference, this proceeding may be converted without further notice into a conference hearing or summary proceeding for disposition of the matter as provided by KAPA. K.S.A. 77-5169(c)(7).

Electronic service shall occur by 3:00 p.m. on the date due, unless otherwise set forth in this or another order. The parties shall specify this electronic service constitutes official service and that no hard copy will follow, making clear that paper copies will not be provided to the parties. In addition, the parties shall include the Prehearing Officer on all electronic service of testimony and briefs at b.fedotin@kcc.ks.gov. The parties are still required to file the original and seven paper copies with the Commission by 5:00 p.m., on the date scheduled for service. K.A.R. 82-1-215(a). Any electronic service or filing received after the deadline set forth in the procedural schedule, shall be accompanied by a Motion to File Out of Time.

Any party who fails to attend or participate in the hearing or in any other stage of this proceeding may be held in default under the KAPA. K.S.A. 77-516(c)(8); K.S.A. 77-520.

D. Electronic service is approved for all testimony and briefs among the parties, and for orders of the Commission and Prehearing Officer, without follow-up hard copies. But the Commission requires the filing of the original and seven paper copies with the Commission.

E. This Order shall be served by electronic mail, with a note that no hard copy will follow. This Order is procedural and constitutes non-final agency action. K.S.A. 77-607(b)(2). Parties have 15 days from the date of electronic service of this Order to petition the Commission for reconsideration. K.S.A. 66-118b; K.S.A. 2011 Supp. 77-529(a)(1).

F. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders, as it may deem necessary.
