### ORDER GRANTING CURB'S PETITION TO INTERVENE

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed its files and records, and being duly advised in the premises, the Commission makes the following findings:

- 1. On March 31, 2015, Kansas City Power & Light Company (KCP&L) filed an Application with the Commission for approval of its 2015 Energy Efficiency Rider for program costs incurred January 1 through December 31, 2014.
- 2. On April 08, 2015, the Citizens' Utility Ratepayer Board (CURB) filed its Petition to Intervene, citing its statutory authority to represent residential and small commercial ratepayers. CURB also contends the rates paid and services received by residential and small commercial customers may be substantially affected in this proceeding.<sup>1</sup>
- 3. The Commission finds CURB has demonstrated an interest in this proceeding. Therefore, pursuant to K.S.A. 77-521, the Commission grants CURB's Petition to Intervene.
