- 1. The Commission is authorized to assess the expenses of a proceeding, opened upon its own motion, on complaint, or upon an application to it, if the expenses attributable to the investigation exceed the sum of \$100.\frac{1}{2}\$ Therefore, if the \$100 threshold is met in this matter, the Commission will assess these expenses against Southwestern Bell Telephone Company, LLC and Brightspeed Broadband, LLC.
- 2. Expenses attributable to this docket shall be assessed beginning three (3) days after the notice of assessment is given by service of this Order. Southwestern Bell Telephone Company, LLC and Brightspeed Broadband, LLC are hereby notified that they have the right to request a hearing regarding this assessment in accordance with the provisions of the Kansas

THEREFORE THE COMMISSION ORDERS THAT:

A. Southwestern Bell Telephone Company, LLC and Brightspeed Broadband, LLC are assessed the costs of this proceeding.

B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).³

C. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it may deem necessary.
