**STATUS UPDATE RECOMMENDING 30-DAY EXTENSION**

On May 6, 2025, the Commission issued an Order Approving Compliance Agreement (Agreement) in this docket.<sup>1</sup> The Agreement provides that Operator may request an extension of time to achieve compliance for up to 30 days from an applicable deadline established under the Agreement upon good cause shown.<sup>2</sup>

On July 7, 2025, Operator requested a 30-day extension of its July 1, 2025, deadline. The District #1 Supervisor believes Operator's reasons for the request demonstrated good cause for an extension. Under the Agreement, Commission Staff recommends that Operator's July 1, 2025, deadline be extended to August 1, 2025. All other deadlines would remain the same.
