**AT&T KANSAS NOTICE OF FILING OF
AMENDED APPLICATION EXHIBITS "A" AND "C"**

COMES NOW Southwestern Bell Telephone Company d/b/a AT&T Kansas (hereinafter "AT&T Kansas"), pursuant to K.A.R. 82-1-218 and K.A.R. 2015 Supp. 82-1-219, and respectfully notifies the Commission that it is hereby filing amended Exhibits "A" and "C" to its October 27, 2016, Application, as follows:

1. The attached amended Exhibits "A" and "C" correct inadvertent errors and omissions in the original, filed exhibits. None of the amendments substantively change AT&T Kansas' requested relief. Correction of these exhibits will ensure the Commission has a complete and accurate record in this proceeding.

Amended Exhibit A

- **Topeka Exchange** - Two wire center/exchange references, TPKAKSRI and TPKAKSWA, have been removed because these wire centers are part of the TPKAKSCA wire center. Similarly, the exchange names previously attributed to wire centers TPKAKSLE, TPKAKSNO, TPKAKSFA and TPKAKSCA, have been amended to reflect the wire centers' status as zones in the Topeka Exchange;

- **Kansas City Exchange** - the exchange names previously attributed to wire centers KSCYKSNB, KSCYKSBS and KSCYKSOL, have been amended to reflect the wire centers' status as zones in the Kansas City Exchange;
- **Wichita Exchange** - the exchange names previously attributed to wire centers WCHTKSBE, WCHTKSCZ, WCHTKSGM and WCHTKSWW, have been amended to reflect the wire centers' status as zones in the Wichita Exchange;
- The Atwood, Basehor, Clinton, Norton, and Reading exchanges have been added to the exhibit. Each of them is part of an arrangement where two or more exchanges share the same wire center/CLLI code. Atwood shares the same wire center/CLLI code with Herndon; Basehor shares with Kansas City; Clinton shares with Lawrence; Norton shares with Norcatur; and, Reading shares with Emporia. The Atwood, Basehor, Clinton, Norton and Reading, exchange designations were inadvertently omitted from the initial exhibit;
- The Elwood and Treece exchanges and their corresponding wire center/CLLI codes, STJSMODN and PCHROKMA, respectively, have been added to the exhibit. Both are Kansas exchanges served by wire centers in Missouri and Oklahoma, respectively. Both were inadvertently omitted from the initial Exhibit A.
- Clerical errors in the names/designations of wire centers: BLRPKSCA; CDWRKSLU; ELWOKSNO; LACRKSEL; LVWOKSLN; LVWOKSSH; PHBGKSO4; and SEDNKSCH, have been corrected.

None of the corrections in Amended Exhibit A affects Exhibit B.

Amended Exhibit C

- The amendment removes Budget Prepay, Inc., as a Competitive Eligible Telecommunications Carrier ("CETC") in AT&T Kansas' service territory;
- The amendment adds Nex-Tech, LLC, which is a CETC in AT&T Kansas' service territory.

2. Counsel for AT&T Kansas has discussed the need for these amendments and this filing with counsel for the KCC Staff, and is authorized to state that Staff does not object to the filing of the amended exhibits.
