RESPONSE OF THE EMPIRE DISTRICT ELECTRIC COMPANY TO MOTIONS OF CURB

COMES NOW The Empire District Electric Company ("Empire") and files this response to the motion of Citizens' Utility Ratepayer Board ("CURB") to deny Empire's request for expedited approval of its Application in this docket.

1. On January 29, 2010, Empire filed an Application for approval of the following: (1) a portfolio of energy efficiency and demand response programs for its Kansas customers established in conjunction with Docket Nos. 08-GIMX-441-GIV ("441 Docket") and 08-GIMX-442-GIV ("442 Docket"); (2) cost recovery, including a Demand Side Management Cost Recovery Rider ("Rider") to recover the cost associated with its portfolio of energy efficiency and demand response programs and to recognize changes in customer consumption as identified by the Commission in its Final Order in Docket 441; (3) to obtain any necessary waivers of the requirements set forth by the Commission in the 441 Docket and 442 Docket; and (4) specific Commission authority to defer all program costs and accrued revenue pursuant to the proposed Rider.

2. A document entitled "Motions of CURB" was filed February 12, 2009. In part, CURB opposed Empire's request for an expedited schedule in this case.

3. As suggested by CURB in its motions, Empire did indicate in its Application it had

coordinated its filing with Staff and had incorporated feedback from Staff into its proposed programs. This was done to satisfy the suggestion set forth in the Kansas Corporation Commission's ("Commission") Order dated April 13, 2009, in the 442 Docket, p. 12, para. 33. However, the statement about Empire's efforts to "coordinate" its filing with Staff was not meant to suggest the Staff had accepted the proposals included in the Application. Empire acknowledges that Staff never indicated to Empire it accepted Empire's proposals.

4. Empire has discussed its request for an expedited schedule in this matter with Staff and CURB and has discussed CURB's objection to said request. Based upon those discussions, Empire has agreed to withdraw its request for an expedited schedule and is currently working with Staff, CURB and the other intervenors on a schedule that might be acceptable to all parties so such can be submitted to the Commission for its approval.

5. Empire has no objection to the other portions of the Motions of CURB.

WHEREFORE, Empire withdraws its request for an expedited schedule in this matter and will work with Staff, CURB and the other intervenors on a schedule that might be acceptable to all parties so such can be submitted to the Commission for its approval.
