JOINT MOTION TO ADOPT PROPOSED PROCEDURAL SCHEDULE

COME NOW, Midwest Energy, Inc. (Midwest), the Staff of the State Corporation Commission of the State of Kansas (Staff) and the Citizens' Utility Ratepayer Board (CURB) (collectively, "Joint Movants"), and jointly file their motion for an order of the State Corporation Commission of the State of Kansas (Commission) adopting the proposed procedural schedule, as more fully set out below, in the above-captioned matter. In support of their motion, Joint Movants state:

- 1. On March 24, 2006, Midwest filed its Application requesting Commission approval to make changes in its charges for natural gas service. The matter was suspended on April 3, 2006, for 240 days, in order to allow Staff and other parties sufficient time in which to fully review, consider and analyze Midwest's Application. CURB sought intervention on March 27, 2006, which was granted on April 3, 2006. To date, CURB is the only intervener in this docket.
- 2. For the orderly conduct of this proceeding, Joint Movants propose that the Commission adopt the following procedural schedule:

Joint Movants believe that the above schedule will allow the parties adequate time in 3. which to review and respond to Midwest's rate filing and will allow for a Commission decision in this matter to be made within the 240-day statutory deadline.
