STAFF'S RESPONSE TO TAG MOBILE, LLC'S MOTION TO DISMISS SHOW CAUSE OR FOR EVIDENTIARY HEARING

The Staff of the Kansas Corporation Commission (Staff and Commission, respectively) hereby responds to TAG Mobile, LLC's (TAG) *Motion to Dismiss Show Cause or for Evidentiary Hearing*. In support of its response, Staff states as follows:

- 1. On January 14, 2016, in this docket, the Commission ordered TAG to show cause why it should not be subject to sanctions and fines and its ETC designation should not be cancelled, suspended and/or revoked.¹
- 2. On February 17, 2016, TAG filed an initial response to the Commission's show cause Order, asking the Commission to "find TAG has not violated the federal or Kansas ETC rules, dismiss this show cause proceeding, and order such other relief as the Commission deems appropriate."²
- 3. On February 26, 2016, Staff responded to TAG's initial response, requesting that "the Commission find that TAG has violated the federal and Kansas ETC rules for the provisioning of Lifeline service in Kansas, strongly consider revocation of TAG's ETC designation, and find that a specific penalty is warranted once more is known."

4. On March 10, 2016, TAG filed a subsequent motion in this docket, again asking

the Commission to find that TAG is not in violation of state or federal statutes, rules or orders as

Staff alleged, and to issue an Order to that effect. TAG also asked, in the alternative, that the

Commission schedule an evidentiary hearing in this proceeding and issue a Protective Order and

a Discovery Order, and grant such other relief as the Commission deems appropriate.⁴

5. Staff now responds to TAG's Motion to Dismiss Show Cause or for Evidentiary

Hearing, not in order to add any new arguments, but simply to reiterate and reaffirm Staff's

arguments and position in the aforementioned Staff's Response to TAG Mobile, LLC's Response

to Show Cause Order, filed in this docket on February 26, 2016. In doing so, Staff wishes to

make clear its view that dismissal is unwarranted in this proceeding.

Further, while Staff acknowledges TAG's right to request a hearing⁵ in this matter 6.

and Staff is willing to go to hearing, based on the above-referenced show cause Order and

responses by TAG and Staff, Staff believes the Commission has an ample basis to take action in

this matter.

WHEREFORE, Staff respectfully requests the Commission find that TAG's motion to

dismiss is unwarranted in this proceeding, that TAG has violated the federal and Kansas ETC

rules for the provisioning of Lifeline service in Kansas, strongly consider revocation of TAG's

ETC designation, that a specific penalty is warranted once more is known, and deny TAG's

request for an evidentiary hearing.
