Madison Telephone applies to amend its video service authorization to include the following footprint.

LEGAL DESCRIPTION:

The service area includes the following described areas in Coffey County, KS

SERVICE AREA FROM NEW STRAWN TO LEBO, WAVERLY AND 35:

In Coffey County, Kansas, beginning at the intersection of 17th Road and Lynx Road, New Strawn, KS; THEN North on Lynx Road 8 Miles (from the Southwest corner of Section 27, Township 20 South, Range 15 East to the Northeast corner of Section 22 Township 19 South, Range 15 East); THEN East 1 mile on 25th Road (along the north line of Section 22, Township 19 South, Range 15 East) to the intersection of 25th Road and Hwy 75; THEN North one mile (along the East line of Section 15, Township 19 South, Range 15) to the Intersection of Hwy 75 and Old Hwy 50; splitting in THREE directions:

West to Lebo (area 1)

SERVICE AREA FROM 75 HWY to LEBO (AREA 1):

Beginning at the intersection of Hwy 75 and old Hwy 50; THEN West 7 miles along old Hwy 50 to the intersection of old Hwy 50 and Ogden Street (from the Northeast Corner of Section 15, Township 19 South, Range 15 West to the Northwest corner of Section 15, Township 19 South, Range 14); THEN North on Ogden Street, in the City of Lebo, to the intersection of Ogden Street and 3rd Street; THEN West on 3rd Street to the intersection of 3rd Street and Pine Street; THEN North on Pine to the Southwest corner of Block 21, Lot 12 West Lebo Supplemental Addition to the City of Lebo; splitting in TWO directions: East across Ogden Street to the endpoint on the Southeast corner of Block 9, lot 7 City of Lebo and the Southwest corner of Block 21, Lot 12 West Lebo Supplemental Addition to the City of Lebo North on Pine to Southwest corner of Block 23, Lot 6 West Lebo Supplemental Addition to the City of Lebo splitting in TWO directions: East to an endpoint on the southwest corner of Block 23, Lot 3 and from Southwest corner of Block 23, Lot 6 West Lebo Supplemental Addition to the City of Lebo North on Pine Street to the intersection of Pine Street and 4th Street; THEN East across Pine Street to Southeast corner of Block 29, Lot 12 West Lebo Supplemental Addition to the City of Lebo; THEN North to the Northeast corner of Block 29, Lot 12, West Lebo Supplemental

East To Waverly (Area 2)

SERVICE AREA FROM 75 HWY to WAVERLY (AREA 2):

Beginning at the intersection of Hwy 75 and old Hwy 50; THEN East 7 miles along old Hwy 50 to the intersection old Hwy 50 with Hwy 31 (also known as Trefoil Road) (from the Northeast Corner of Section 14, Township 19 South, Range 15 East to the Northeast corner of Section 15, Township 19 South, Range 16); THEN South to the intersection of 8th Street and Trefoil Road (at that point also known as Pierson Ave) Waverly, KS; THEN West on 8th Street to the northwest corner of Block 37, Lot 8 McFadden's 3rd Addition to the City of Waverly; THEN South to the Southwest corner of Block 37, Lot 1 McFadden's 3rd Addition to the City of Waverly, where it intersects with 7th Street; THEN West to Schofield Street; Then South along Schofield Street to the intersection with 6th Street; THEN from that point splitting in TWO directions: West along 6th Street to an endpoint intersecting with the Southwest corner of Block 6, Lot 7 McFadden's 2ND Addition to the City of Waverly, and East along 6th Street to the Northeast corner of Block 1, Lot 7 McFadden's 1ST Addition to the City of Waverly; THEN at that point splitting in TWO directions: East along 6th Street to an endpoint of the Northeast corner of Block 4, Lot 18, Pearson's Addition to the City of Waverly and South beginning at the Northeast corner of Block 1, Lot 7 McFadden's 1st Addition to the City of Waverly; THEN South to the Southwest corner of, Block 6, Lot 3 Kent's Addition to the City of Waverly intersecting with 3rd Street; THEN East to the intersection of 3rd Street and Pierson Ave; THEN in a Northeasterly direction along 3rd Ave to an endpoint in the Southeast corner of, Block 3, N22' Of lot 1, City of Waverly, all in Coffey County Kansas.
