ORDER GRANTING EXTENSION OF TIME TO FILE RESPONSE TO ANSWER

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined and considered DH Pace Company's Motion for Extension of Time, the Commission finds as follows:

1. On July 22, 2015, DH Pace Company (DH Pace) filed with the Commission a Complaint against Atmos Energy.
2. On August 25, 2015, Atmos Energy filed its Answer to DH Pace's Complaint, which was received by DH Pace on August 28, 2015.
3. On September 8, 2015, DH Pace filed a Motion for Extension of Time, requesting until September 11, 2015, to review Atmos Energy's Answer to DH Pace's Complaint and file a response to said Answer. Commission Staff (Staff) has no objections to DH Pace's requested extension of time and recommends approval of DH Pace's motion.
4. The Commission finds Staff's recommendation to be reasonable and hereby adopts the same.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

- A. DH Pace's Motion for Extension of Time until September 11, 2015 to respond to Atmos Energy's Answer is hereby granted.


