ORDER SETTING HEARING

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having reviewed the pleadings and record, the Commission finds and concludes as follows:

- 1. The Commission issued a Penalty Order to B-C Steel, LLC (B-C Steel) on October 31, 2013¹ because it found the Ankrom wells have been inactive in excess of the time allowed by K.A.R. 82-3-111 without being plugged, returned to service, or approved for Temporary Abandonment status.²
- 2. B-C Steel timely filed its Request for Hearing stating it has never operated the Ankrom wells or even physically entered the leasehold property on which the wells are located.³
- 3. The Commission finds this matter should be set for hearing to investigate the claims by B-C Steel. The hearing will be held on February 21, 2014, at 10:00 a.m., or as soon thereafter as scheduling permits, at the Kansas Corporation Commission, 130 S. Market, Room 2078, Wichita, Kansas 67202. The Commission will preside over this hearing. The hearing will

be formal in nature and will involve both the rules of civil procedure and the rules of evidence. Please note that K.A.R. 82-1-228(d)(2) requires corporations to appear through an attorney.

- 4. Pursuant to K.A.R. 82-1-229, Commission Staff must pre-file direct testimony by February 3, 2014, and B-C Steel must pre-file direct testimony by February 11, 2014. One original and seven copies of pre-filed direct testimony must be filed with the Executive Director, 130 S. Market, Room 2078, Wichita, Kansas 67202. Rebuttal testimony may be presented at the hearing.
- 5. Any person requiring special accommodations under the Americans with Disabilities Act needs to give notice to the Commission at least 10 days prior to the scheduled hearing date.

- A. B-C Steel's Request for Hearing is granted.
- B. The hearing will be held on February 21, 2014, at 10:00 a.m., or as soon thereafter as scheduling permits, at the Kansas Corporation Commission, 130 S. Market, Room 2078, Wichita, Kansas 67202.
- C. The parties have fifteen days, plus three days if service of this order is by mail, from the date this Order was served in which to petition the Commission for reconsideration.⁴
