





2. On August 12, 2014, the Commission issued an order approving the Agreement.

3. Atmos Energy has met with Staff and has provided documentation confirming the items set forth in the Agreement, and restated in paragraph 1 of this Notice pleading, have been completed in compliance with the terms of the Agreement. Staff has reviewed the documentation and found the documentation to be adequate, as provided by Atmos Energy in compliance with the terms set forth in the Agreement. Accordingly, Atmos Energy moves the Commission to issue an order in this docket finding the items identified in the Agreement have been completed by Atmos Energy and this docket can be closed.

WHEREFORE, for the reasons set forth herein, Atmos Energy requests its motion be granted and for such other further relief the Commission may deem appropriate.




