MOTION FOR DEFAULT ORDER

The Staff of the State Corporation Commission of the State of Kansas ("Staff" and "Commission," respectively), moves the Commission for a Default Order to be issued against the Operator and the Protester. In support of its motion, Staff states as follows:

- 1. On October 29, 2018, RedBud Oil & Gas Operating, LLC (Operator) filed an Application to authorize injection of natural gas into the Cattleman formation at the Westfall #2E-12 well.¹
- 2. On November 20, 2018, Arlyn Hare, Director of Eagle Oak Land Development, (Protester) timely filed a letter of protest.
- 3. On January 15, 2019, the Commission issued an order setting this matter for an April 18, 2019, Evidentiary Hearing.²
- 4. On January 31, 2019, a Prehearing Officer Order was issued scheduling a Status Conference in this docket for February 15, 2019.
- 5. Counsel for Staff appeared at the pre-hearing conference on February 15, 2019, but both the Operator and Protester failed to appear.
- 6. Pursuant to K.S.A. 77-520(a), "[i]f a party fails to attend or participate in a prehearing conference, hearing or other stage of an adjudicative proceeding, the presiding officer

may serve upon all parties written notice of a proposed default order, including a statement of the

grounds."

7. Staff believes Operator and Protester were both properly notified and afforded an

opportunity to attend and participate in the February 15, 2019, prehearing conference, but failed

to do so. Therefore, Staff requests that a default order be issued against the Operator and the

Protester dismissing both the Application and Protest in this docket.

WHEREFORE, for the reasons set forth above, Staff respectfully requests the

Commission issue a default order against Operator and Protester dismissing the Application and

the Protest filed in this docket, for failure to appear and participate, and for any further relief as

the Commission deems just and proper.


