**JOINT MOTION FOR PROCEDURAL SCHEDULE**

COME NOW, the Empire District Electric Company, a Liberty Utilities Company (“Empire”), Kansas City Power & Light Company (“KCP&L”), Westar Energy, Inc. and Kansas Gas and Electric Company (referred to together herein as “Westar”), Kansas Electric Cooperatives, Inc. (“KEC”), Southern Pioneer Electric Company (“Southern Pioneer”), the Citizens’ Utility Ratepayer Board (“CURB”) and the Staff of the State Corporation Commission of the State of Kansas (“Staff” and “Commission,” respectively) collectively referred to as “Joint Movants,” and hereby move the Commission for an order establishing a procedural schedule. In support of their motion, Joint Movants state the following:

1. On July 24, 2018 the Commission issued its Order Opening General Investigation to fully investigate the parameters and intricacies of a customer opt-out program for advanced metering infrastructure digital electric meters.
2. As directed by the Commission’s July 24, 2018 Order, Empire, KCP&L, Westar and Southern Pioneer entered their respective appearances in this proceeding. KEC and CURB petitioned for and were granted intervention in this proceeding.
3. The proposed procedural schedule agreed to by Joint Movants is as follows:
