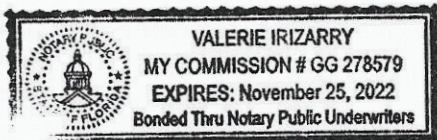

1. As of June 12, 2020, Q Link has corrected its reporting procedures to ensure intrastate retail revenues are allocated to Kansas using the correct Safe Harbor rate.
2. As of July 28, 2020, Q Link has corrected its reporting procedures to ensure Box C of the Carrier Remittance Worksheets provides for the inclusion of actual KUSF assessment surcharges collected from customers (rather than the amount of the assessment owed by Q Link).
