ORDER DESIGNATING PREHEARING OFFICER AND SETTING PREHEARING CONFERENCE

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds and concludes as follows:

1. On December 8, 2016, Commission Staff (Staff) issued a Penalty Order to Tontol,

LLC (Operator), stating that the Operator committed one violation of K.A.R. 82-3-407 because a current, successful mechanical integrity test (MIT) had not been performed on the Fussman #19 well.

2. On January 12, 2017, Operator timely filed its request for a hearing in this matter.

Upon its own motion and pursuant to K.S.A. 77-551(c), the Commission finds 3. that a Prehearing Officer should be designated in this proceeding to address any matters listed in K.S.A. 77-517(b), and a Prehearing Conference should be scheduled.

Although a Prehearing Officer is designated in this docket, parties are still 4. required to file pleadings with the Commission, and filings shall be made with the Commission's Docket Room before 5:00 p.m. on the date scheduled for service. Any electronic service received after the deadline set forth in the procedural schedule, or any filing made after 5:00 p.m. on the date scheduled for service, shall be accompanied by a Motion to File Out of Time.

THEREFORE, THE COMMISSION ORDERS:

The Prehearing Officer in this proceeding shall be Michael J. Duenes, Assistant A. General Counsel, Kansas Corporation Commission, 1500 SW Arrowhead Road, Topeka, Kansas, 66604-4027, telephone number (785) 271-3181, email address m.duenes@kcc.ks.gov. The Commission may designate other Staff members to serve in this capacity.

A Prehearing Conference is scheduled for Thursday, February 23, 2017, at 9:30 B. a.m. by telephone. The conference call information is: telephone number (866) 620-7326, Conference Code PIN: 7632914771#.

C. At the Prehearing Conference, parties shall be prepared to discuss deadlines for filing testimony and briefs, discovery procedures, scheduling of a hearing with the Commission, and any other issues that will promote the orderly and prompt resolution of this proceeding.

At the Prehearing Conference, without further notice, this proceeding may be D. converted into a conference hearing or a summary proceeding for disposition of this matter as provided by the Kansas Administrative Procedure Act (KAPA). Any party that fails to attend or participate in the Prehearing Conference, hearing, or other stage of this proceeding may be held in default under the KAPA.¹

A corporation shall appear before the Commission by its attorney.² E.
