ORDER

NOW, the above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

1. On November 3, 2005, Southwestern Bell Telephone, L.P. d/b/a SBC Kansas (SWBT) filed an application for approval of a modification to the interconnection agreement (Agreement) between SWBT and Trinsic Communications, Inc. (Trinsic). The Agreement was previously approved on October 26, 2005.

2. This modification amends the Agreement to supersede certain reciprocal compensation provisions through October 1, 2010. The Agreement, with these modifications and the attachments incorporated therein, is an integrated package and is the result of negotiation and compromise. This amendment was previously approved by the Commission in Docket No. 03-SWBT-045-IAT.

3. There are no outstanding issues between the parties that need the assistance of mediation or arbitration. Trinsic is properly registered with the office of the Kansas Secretary of State and is currently listed as “active and in good standing” with that office.

4. SWBT files the modification to the Agreement seeking Commission approval of its terms and conditions consistent with the Federal Telecommunications Act of 1996. SWBT represents and believes in good faith that the implementation of the modification to this Agreement is in the public interest, convenience and necessity, and does not discriminate against any telecommunications carrier.

5. SWBT specifically requests that the Commission refrain from taking any action to change, suspend, or otherwise delay implementation of this agreement, in keeping with the support of competition previously demonstrated by the Commission.

6. The Commission finds and concludes that the modification to the Agreement between SWBT and Trinsic should be approved. The implementation of the modification is consistent with the public interest, convenience and necessity and does not, on its face, discriminate against any telecommunications provider not a party to the agreement.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. The application of Southwestern Bell Telephone, L.P. for approval of a modification to the Interconnection Agreement with Trinsic Communications, Inc., is hereby approved.

B. The parties have fifteen days, plus three days if service of this order is by mail, from the date this order was served in which to petition the Commission for reconsideration of any issue or issues decided herein. K.S.A. 66-118b; K.S.A. 2003 Supp. 77-529(a)(1).

C. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further order, or orders, as it may deem necessary.


