PREHEARING OFFICER ORDER REGARDING ELECTRONIC SERVICE

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

1. On May 6, 2019, Jim Snyder, Inc. (Operator) filed an Application for injection authority at three wells in Butler County.¹
2. On May 23, 2019, Flint Hills Land & Cattle Co. (Protestor) filed a protest.² On June 6, 2019, the Commission issued an order setting a June 21, 2019, prehearing conference.³
3. At the June 21, 2019, prehearing conference, all parties consented to the electronic service of all documents⁴ and orders.⁵ Therefore, the Prehearing Officer directs that service of all documents and orders may be made by email. To the extent that it is practicable, any electronically served document or order shall be attached to the email and served in pdf format. Service of orders is

complete upon transmission.⁶ Parties are encouraged to make sure large pdf files do not result in delivery failure and to work together to resolve any email-based service issues.

The Prehearing Officer notes that filing of documents with the Commission must still be done either through the Commission’s “e-filing express” system, or by mail or hand delivery to the Commission.¹⁰ The Prehearing Officer orders that if a document is filed by mail or hand delivery, only the original copy must be supplied.¹¹ The Commission, however, strongly encourages parties to file through the “e-filing express” system.¹²
