
**STATUS UPDATE TO COMPLIANCE AGREEMENT**

On November 22, 2016, the Commission issued an Order Approving Compliance Agreement (Agreement) in this docket. The Agreement provides that the Agreement may be amended to add additional wells with the written consent of both the Operator and Staff.<sup>1</sup>

District 3 Staff recommends amending this Agreement to add the following additional wells: the Gregory, Lary South #2, API #15-099-30120-00-00; and the Beard #OW-2, API #15-031-19338-00-00 (subject wells). The Operator has expressed a desire to plug the subject wells and is not opposed to the addition of the subject wells to the Agreement. Staff has obtained the written consent of the Operator, as evidenced by the attached email correspondence.

Staff hereby consents to adding the subject wells to the Agreement.
