**ORDER ADOPTING AUDIT REPORT AND CLOSING DOCKET**

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and record, and being duly advised in the premises, the Commission finds and concludes as follows:

1. On August 2, 2016, the Commission directed GVNW Consulting, Inc. (GVNW) to perform an audit of Cricket Communications, Inc. (Cricket) for Kansas Universal Service Fund (KUSF) purposes.

2. On June 15, 2017, GVNW filed its Audit Report of even date indicating its finding that Cricket's KUSF account is closed and the company does not have any outstanding KUSF obligations. GVNW's review addressed an earlier audit compliance follow-up from Docket No. 13-CRCZ-712-KSF which included the following:

Other KUSF-Related Finding: Cricket identified the KUSF and Federal Universal Service Fund (USF) surcharges on a customer's bill as "Universal Service Fund Surcharge", but did not clearly identify whether the charge is for Kansas or the Federal jurisdiction.

Audit Finding Compliance: For the audit period, the Company did not collect the KUSF or Federal USF surcharges from its subscribers. Therefore, the customer's bill did not reflect any line item associated with the Kansas or Federal jurisdiction.

GVNW did not identify any KUSF audit deficiencies related to the current audit period and recommends closing this docket.

3. The Commission has reviewed GVNW's June 15, 2017 Audit Report and concludes that it should adopt the same and close this docket.

**IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:**

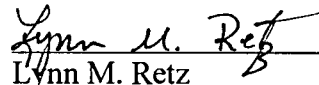
A. The Commission accepts and adopts GVNW Consulting, Inc.'s Audit Report filed June 15, 2017. This docket is hereby closed.
