**KANSAS CITY POWER & LIGHT COMPANY’S MOTION FOR  
MODIFICATION OF SUSPENSION ORDER**

COMES NOW Kansas City Power & Light Company (“KCP&L” or “Company”), and submits the following request for modification of the Kansas Corporation Commission’s (“Commission”) Suspension Order dated August 27, 2013.

1. On August 12, 2013, KCP&L filed an Application seeking approval to modify the original budget for its Demand-Side Management (DSM) pilot program Energy Optimizer.
2. On August 27, 2013, the Commission issued a Suspension Order pursuant to K.S.A. 66-117(c) suspending the Application for a period of 240 days, until April 9, 2014.
3. KCP&L requests that the Application be further suspended until June 9, 2014 so that it may continue to work with Commission Staff on issues arising out of the Application. KCP&L hereby agrees to an extension of the 240-day period, as provided for under K.S.A. 66-117(c).

WHEREFORE, KCP&L prays that the Commission modify the Suspension Order as outlined above and for such further order or orders as the Commission may deem appropriate.

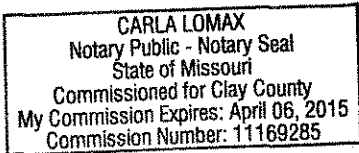
