- 2. On January 22, 2025, Staff requested the procedural schedule be modified to allow additional time to resolve the Goddard, Kansas, phase of this docket. Neither Kansas Gas Service nor Black Hills opposed Staff's request, which the Commission approved. The Goddard, Kansas, portion of this docket has concluded.
