MOTION TO CLOSE DOCKET

The Staff of the State Corporation Commission of the State of Kansas ("Staff" and "Commission," respectively) files this *Motion to Close Docket*. In support of its Motion, Staff states as follows:

1. On July 19, 2017, Staff filed a motion to show cause against Operator, due to a unplugged well remaining on Operator's expired license in violation of Commission regulations.
2. On August 22, 2017, the Commission issued an *Order to Show Cause*, setting a September 14, 2017, prehearing conference, most recently continued to February 8, 2018.
3. In early February 2018, Operator plugged the well remaining on Operator's license. Thus, Operator has satisfactorily resolved all issues that had caused Staff to initiate this proceeding.

WHEREFORE, as no issues remain to be resolved, Staff respectfully moves the Commission for this docket to be closed.

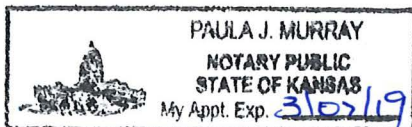
