COMES NOW Kansas Gas and Electric Company, doing business as Westar Energy (Westar Energy), and in support of its Application To Cease states:

1. Westar Energy is a Kansas corporation authorized by the Commission to conduct the business of a public utility under the provisions of K.S.A. 66-104, and as such holds a Certificate of Convenience and Authority from this Commission to engage in the business of an electric public utility in the State of Kansas, thereby promoting the public convenience in the following described territory:

BUTLER COUNTY, KANSAS

A tract of land described as the East ¹/₂ of the Northwest ¹/₄ of Section 12, Township 25 South, Range 4 East, in Butler County, Kansas, as detailed on the map marked Exhibit A and attached hereto.

2. A new customer has plans to build a residence and barn in the property described in paragraph 1. Butler Rural Electric Cooperative Association, Inc. (Butler REC) has an existing service line that runs along the west fine line of the property. Westar Energy's closest service is approximately ¹/₂ mile away from the property described in paragraph 1. In order for Westar Energy to serve this customer it would require additional financial burden.

3. There are no customers currently being served by Westar Energy in this territory.

4. Westar Energy and Butler REC have mutually agreed, subject to the Commission's approval, that as a matter of public convenience and to better serve the customer base, Butler REC should serve as an electric public utility in the territory described in paragraph 1.


