MOTION FOR EXPEDITED HEARING ON APPLICATION


COMES NOW Keith F. Walker Oil & Gas Co., LLC, and moves the Commission for an Order re-scheduling and expediting hearing on the application in this docket.

In support of this Motion, Movant shows to the Commission as follows:

1. The application in this docket was filed on April 16, 2008, seeking a spacing and proration order affecting the captioned lands in Meade County, Kansas.
2. While said application is pending before the Commission, all parties with lease interests in the area sought to be spaced and prorated are prohibited from commencing drilling operations at locations that do not conform to the most restrictive location provisions requested in said application. Accordingly, movant is prevented from continuing its planned drilling program during pendency of this docket, to its detriment.
3. The application requested that the Commission set a hearing on July 17, 2008; however, the Commission has a regularly-scheduled hearing date of June 26, 2008.

4. Conducting the hearing in this docket on June 26, 2008, or at an earlier special setting, would still provide sufficient time for pre-filing of testimony and exhibits in accordance with the Commission's rules and regulations.

WHEREFORE, Movant prays that the Commission re-schedule the hearing in this docket on applicants' application for spacing and proration to June 26, 2008, in Wichita, Kansas, or such earlier date as the Commission may approve; and for such other relief as the Commission may find proper.




