MOTION TO MODIFY PROCEDURAL SCHEDULE

The Staff of the State Corporation Commission of the State of Kansas ("Staff" and "Commission", respectively) move the Commission for an order modifying the Prehearing Officer Order Lifting Stay and Amending Procedural Schedule issued on July 10, 2017. In support of the Motion, Staff states as follows:

- 1. On September 9, 2016, Southern Pioneer Electric Company ("Southern Pioneer") filed a Formal Complaint against Kansas Power Pool ("KPP").
- 2. On December 15, 2016, the Commission accepted the Complaint and caused it to be served on KPP.
 - 3. On December 22, 2016, KPP filed its Answer to the Complaint.
- 4. On March 10, 2017, Mid-Kansas Electric Company, LLC (Mid-Kansas), petitioned for intervention, and the Commission granted the intervention on March 30, 2017.
 - 5. On March 30, 2017, the Commission issued its first Procedural Order.
- 6. On April 4, 2017, Southern Pioneer and KPP met for the purposes of informally discussing settlement. As a result of those discussions, Southern Pioneer and KPP desired to explore various options that could result in resolution of the issues in this proceeding. However, due to the complexity of the issues, additional time was needed to fully explore the potential settlement options.

- 7. As such, on April 17, 2017, Joint Movants filed a Joint Motion to Stay Procedural Schedule to allow the parties to focus efforts on settlement rather than the drafting of testimony.
- 8. On May 2, 2017, the Commission issued an Order Granting Stay, granting the Joint Motion to Stay Procedural Schedule, staying the proceeding for sixty (60) days, and requiring that Joint Movants provide the Commission a proposed amended procedural schedule at the completion of sixty (60) days.
- 9. On June 2, 2017, the Joint Movants submitted to the Commission a status report, stating that despite settlement discussions, Southern Pioneer and KPP have been unable to reach a full resolution of the issues at this time, and further stating that the Joint Movants intend to file a motion to lift the stay and/or provide the Commission with a proposed amended procedural schedule within the next thirty (30) days.
- 10. Accordingly, on June 20, 2017, the Joint Movants filed their Joint Motion to Lift Stay and Modify Procedural Schedule.
- 11. On July 10, 2017, the Prehearing Officer issued a Prehearing Officer Order Lifting Stay and Amending Procedural Schedule which lifted the stay and approved of the following proposed amended procedural schedule:


