Pursuant to the *Order Adopting Staff's Report and Recommendation* dated November 19, 2015 in the above-mentioned docket, Southwestern Bell Telephone Company d/b/a AT&T Kansas is required to file, on a quarterly basis, an affidavit that identifies the total monthly Kansas Lifeline Service Program (KLSP) credits the Company self-funded to qualifying subscribers. Accordingly, attached for filing is AT&T Kansas' quarterly affidavit for the period of March-May 2017. AT&T Kansas considers the attached information to be Confidential. This information is being provided pursuant to K.S.A. 66-1220a.

The Commission's April 4, 2017 *Order Recognizing AT&T's Decision to Cease Participation in the Kansas Lifeline Service Program* in KCC Docket No. 17-SWBT-158-MIS confirmed AT&T Kansas' exercise of its statutory right to cease participation in the KLSP effective May 31, 2017. As a result, this filing represents AT&T Kansas' final quarterly affidavit filing regarding KLSP self-funded credit information through May 31, 2017, the effective date of its exit from participation in the KLSP.

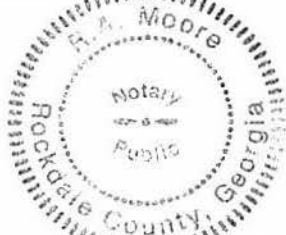
