## PREHEARING OFFICER ORDER CONTINUING PROCEEDING AND SCHEDULING A STATUS CONFERENCE

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

- On July 3, 2018, TGT Petroleum Corporation ("Applicant") filed an Application for an exception to the 10-year time limitation of K.A.R. 82-3-111 for its Wheeler F#1 well located in Kiowa County, Kansas.<sup>1</sup>
- 2. Two protests were subsequently filed in the docket: one by Alan Staab of Voskuhl Staab Family Farms LLC and one by Roger Stotts of Morning Star Farms, GP.<sup>2</sup>
  - On July 31, 2018, a Prehearing Conference was scheduled for August 21, 2018.<sup>3</sup> 3.
  - 4. On August 20, 2018, the Applicant filed a Motion to Dismiss Protests.
- 5. On August 21, 2018, a Prehearing Conference was held. The parties agreed that in light of the Applicant's Motion to Dismiss, the proceeding should be continued to allow for Commission action on the Motion.
