Fireman Larkin Downing contacted our daughter Jessica Jackson by Text message about fire on 2-27-2016 around 6:40pm. We then returned home to the last hot spots being put out. Spoke with Fire fighters where they instructed me to watch for any flare-ups and to wet down base of shop in the morning. They indicated that the fire had started on WESTAR property/pole. This is on the property line of 4711 & 4733 NE Meriden Rd, Topeka, KS 66617. Fire incident report from Soldier Township was not available without Insurance company request per Pam Buckhalter 785-286-2123. Pam.buckhalter@soldiertownship.com

I spoke with WESTAR Supervisor Jarrod Konency 785-865-4868 onsite. Jarrod had confirmed that fire had started on the pole near the primary conductor. He indicated that this happens more often than you would think. An isolator would get a crack in it. The bolt gets hot and cause short to pole which starts fire. He said that the claims department would contact me and that they are good to work with.

With winds at or near 35-40 miles an hour fire spread across property setting grass, mulch, flower gardens, rose bush, garden art, trees, workshop, pool deck lattice and 4x4 supports on fire, 2 sheets of siding on south side of house were melted.

I planted 100lbs of grass seed \$116.15. I had the burned siding on the east side of shop replaced \$1389.46, along with additional sheets of siding replaced to get color to match \$ 862.99 done by C C Construction (Jerry Cook). I had 2 sheets of siding on house replaced that were melted by fire \$430.00 (Home Improvement Gallery). Copies of receipts are included for work that has been done. To Total \$2798.60

Thank you for your response concerning a claim for reimbursement against Westar Energy. You have indicated on February 27, 2016, you suffered damages as a result of a fire on Westar's pole.

After investigating the incident, please understand that as an electric utility regulated by the Kansas Corporation Commission, we are not liable when property damage results from equipment failure, unless that failure is due to our negligence. It has been determined that a transformer switch failed. Westar had no prior knowledge of an imminent failure of the switch.
