**AMENDED APPLICATION FOR A CERTIFICATE OF PUBLIC CONVENIENCE AND  
AUTHORITY TO TRANSACT THE BUSINESS OF AN ELECTRIC PUBLIC UTILITY**

COMES NOW Kansas Gas and Electric Company, doing business as Westar Energy  
(Westar Energy), and in support of its Amended Application for a Certificate of Public  
Convenience and Authority, for Transmission Rights only, states:

Westar Energy is a Kansas corporation authorized by the Commission pursuant to K.S.A.  
66-104 to conduct the business of a public utility, and as such holds a Certificate of Convenience  
and Authority from this Commission to engage in the business of an electric public utility in the  
State of Kansas, thereby promoting the public convenience.

1. Westar Energy seeks, subject to the Commission's approval, transmission rights  
only in the Sumner-Cowley Electric Cooperative, Inc. (Sumner-Cowley) certified territory  
described below:

**SUMNER COUNTY, KANSAS**

**TRANSMISSION RIGHTS ONLY:** Install a new transmission line in Sumner  
County that begins at the existing 345kV Westar Energy transmission line at 1100  
feet west of and 75 feet south of the center section line of Section 20, Township  
31 South, Range 3 West; thence proceeding west approximately 1400 feet where  
it crosses the section line of Section 19, Township 31 South, Range 03 West;  
thence proceeding 1200 feet where in the southeast ¼ it thence turns south and  
proceeds approximately 1650 feet where in the Southeast ¼ it thence turns east,  
proceeding approximately 200 feet, entering the proposed substation; thence  
leaving the substation in the same ¼ section, proceeding southeast 200 feet

southeast into the Southwest ¼ of Section 20, Township 31 South, Range 03 West, thence proceeding southeast 1300 feet where it ties into the existing 345kV Westar Energy transmission line at approximately 100 feet north of the South Section Line in the Southwest ¼ of Section 20, Township 31 South, Range 03 West, in Sumner County, Kansas as shown on Exhibit A, attached hereto.

2. Westar Energy is building this new transmission line in Sumner County to connect the proposed Westar Energy Viola Substation into an existing Westar Energy 345kV transmission line. The new transmission line will connect renewable wind energy generated by Flat Ridge II Wind Farm to the Westar Energy Substation and ultimately to the electrical grid of the Southwest Power Pool.

3. This Amended Application corresponds with the EL Application WR #67162, previously filed with the Commission by Westar Energy.

5. There is no other person or entity, corporate, municipal or otherwise that requires notice of this Amended Application.

THEREFORE, Westar Energy requests that a Certificate of Public Convenience and Authority be issued, granting Westar Energy authority to operate as an electric utility, for transmission rights only, in territory described in paragraph 1 above.

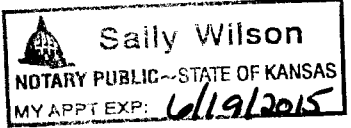

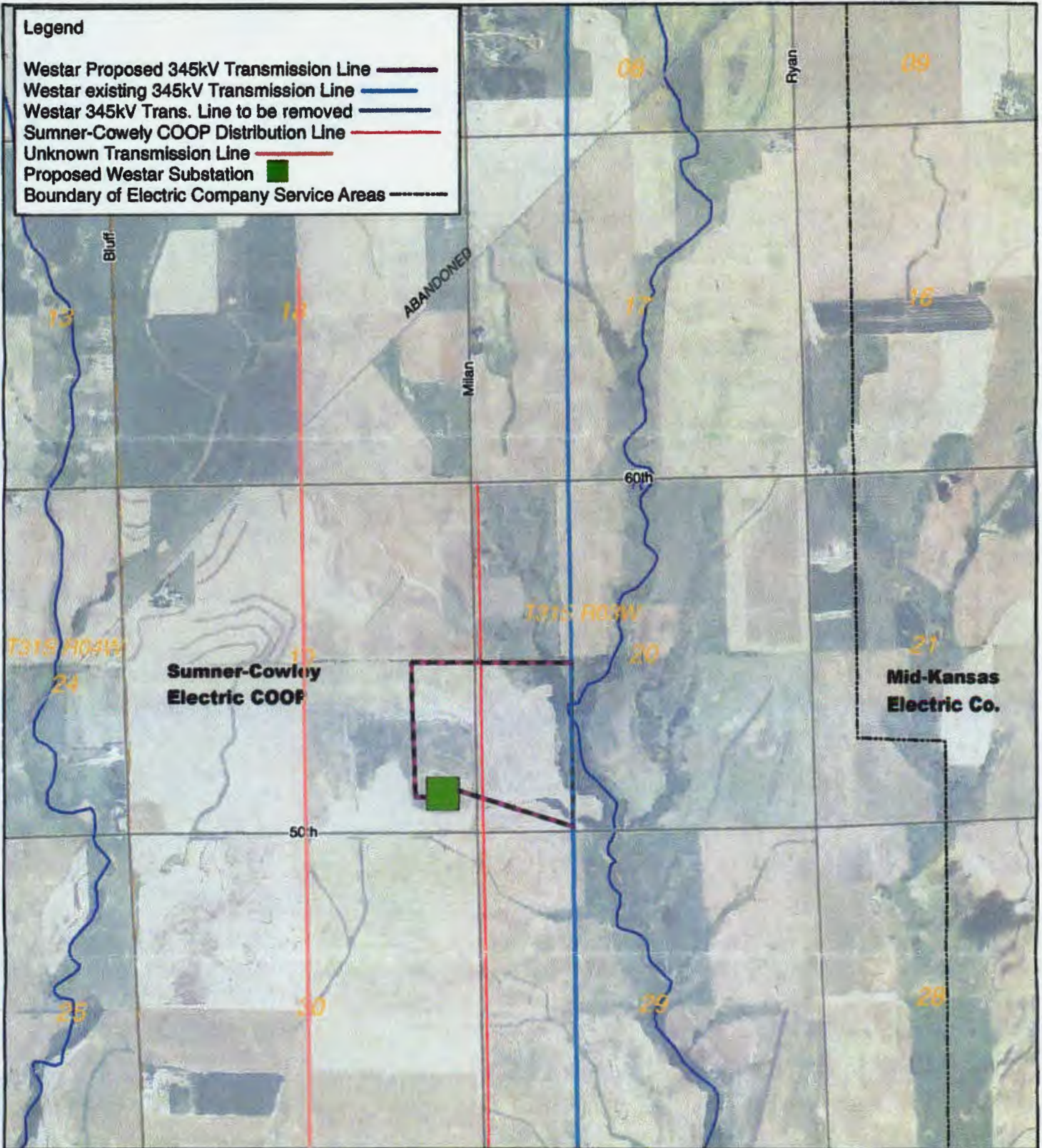
