## **ORDER DESIGNATING PREHEARING OFFICER AND** SETTING PREHEARING CONFERENCE

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds and concludes as follows:

On April 27, 2017, the Commission issued a Penalty Order to SX54, LLC 1.

(Operator) for failure to file an annual fluid injection report or reports, describing well activity during the 2016 calendar year.<sup>1</sup>

2. On June 2, 2017, Operator timely filed its request for a hearing.

3. Upon its own motion and pursuant to K.S.A. 77-551(c), the Commission finds that a Prehearing Officer should be designated in this proceeding to address any matters listed in K.S.A. 77-517(b), and a Prehearing Conference should be scheduled.

4. Although a Prehearing Officer is designated in this docket, parties are still required to file pleadings with the Commission, and filings shall be made with the Commission's Docket Room before 5:00 p.m. on the date scheduled for service. Any electronic service received after the deadline set forth in the procedural schedule, or any filing made after 5:00 p.m. on the date scheduled for service, shall be accompanied by a Motion to File Out-of-Time.

The Commission may designate other Staff members to serve in this capacity.

B. A Prehearing Conference is scheduled for Thursday, July 13, 2017 at 9:00 a.m. by telephone. The conference call information is: telephone number (866) 620-7326, Conference Code PIN: 7632914771#.

C. Subsequent to the above-scheduled Prehearing Conference, status conferences shall be held in this docket every 30 days until such time as a hearing is conducted or a settlement approved.

At the Prehearing Conference, parties shall be prepared to discuss deadlines for D. filing testimony and briefs, discovery procedures, scheduling of a hearing with the Commission, and any other issues that will promote the orderly and prompt resolution of this proceeding.

E. At the Prehearing Conference, without further notice, this proceeding may be converted into a conference hearing or a summary proceeding for disposition of this matter as provided by the Kansas Administrative Procedure Act (KAPA). Any party that fails to attend or participate in the Prehearing Conference, hearing, or other stage of this proceeding may be held in default under the KAPA.<sup>2</sup>

F. A corporation shall appear before the Commission by a Kansas licensed attorney.<sup>3</sup>
