KANSAS CITY POWER & LIGHT COMPANY**



1. In its May 2, 2012 motion, KCPL requests an order from the Commission to terminate certain financial reporting requirements established in the Unanimous Stipulation and Agreement approved by the Commission on August 7, 2001.

2. KCPL alleges, and CURB agrees, that the financial reporting requirements in this docket are duplicative and no longer needed in light of the comprehensive financial reporting requirements established in Docket No. 06-GIMX-181-GIV.

WHEREFORE, CURB respectfully urges the Commission to grant KCPL's request for an Order terminating the quarterly key financial reporting requirements established in this docket.


