**ORDER GRANTING GC PIVOTAL, LLC’S MOTION FOR EXTENSION OF TIME**

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (“Commission”) for consideration and determination. Having reviewed its files and records, the Commission finds and concludes:

1.        On February 24, 2025, GC Pivotal filed a third Motion for Extension of Time to comply. GC Pivotal has requested the deadline be extended until May 16, 2025, to complete compliance with the Audit Report. VPS’s Compliance Report would accordingly be due by June 16, 2025.

2.        On February 24, 2025, Commission Staff (Staff) filed its Response to GC Pivotal’s Motion for Extension of Time, indicating Staff does not oppose GC Pivotal’s motion, Additionally, Staff requested GC Pivotal be required to update Staff on its progress in correcting the deficiencies identified in the Audit Report.

3.        Pursuant to K.A.R. 82-1-217(b) the Commission can extend any deadline for good cause. Nothing in the record indicates that GC Pivotal’s request is in bad faith or designed to unnecessarily delay compliance, therefore the Commission finds its Motion for Extension of Time should be granted for GC Pivotal to correct the deficiencies identified in the Audit Report including

the payment of any billing credits accrued in the billing cycles that followed the filing of the VPS Audit Report, to May 16, 2025. Additionally, the Commission finds that GC Pivotal should provide periodic updates on its progress to Staff by the fifteenth day of each month. The Commission concludes the deadline for VPS to file its compliance report should be extended until June 16, 2025.

**IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:**

A. GC Pivotal, LLC’s Motion for Extension of Time is granted. The deadline for GC Pivotal to correct the deficiencies identified in the VPS Audit Report, as well as the payment of any billing credits accrued in the months after its filing, is extended to May 16, 2025.

B. The deadline for VPS to submit its compliance report is extended to June 16, 2025.

C. GC Pivotal shall provide periodic, informal written updates on its progress to Staff by the fifteenth day of each month until May 15, 2025.

D. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).<sup>1</sup>
