JOINT MOTION TO ACCEPT LATE-FILED EXHIBIT


COME NOW, the Staff of the State Corporation Commission of the State of Kansas (“Staff” and “Commission” respectively), along with Kansas City Power & Light Company (“KCPL”), and the Citizens’ Utility Ratepayer Board (“CURB”) (collectively, “Joint Movants”) and respectfully request that the Commission accept the attached late-filed Appendix E to the Joint Stipulation and Agreement in this proceeding, and make Appendix E part of the Stipulation and Agreement. In support of its motion, Joint Movants state as follows:

1. On September 12, 2007, the Joint Movants submitted a Joint Motion to Approve Stipulation and Agreement in this docket. The Joint Motion explained that the Stipulation and Agreement, which was attached to the Joint Motion, did not include Appendix E. Joint Movants committed to submit Appendix E to the Commission as a late-filed exhibit no later than Friday, September 14, 2007.






