## **STATUS UPDATE GRANTING 30-DAY EXTENSION**

On August 20, 2019, the Commission issued an Order Approving Compliance Agreement (Agreement) in this docket.<sup>1</sup> On June 8, 2023, Commission Staff filed a Motion to Approve Amended Compliance Agreement.<sup>2</sup> On June 20, 2023, the Commission issued an Order Granting Motion to Approve Amended Compliance Agreement.<sup>3</sup> The Amended Agreement provides that Operator may request an extension of time to achieve compliance for up to 30 days from an applicable deadline established under the Agreement upon good cause shown.<sup>4</sup> Staff will grant or deny such request.<sup>5</sup>

On April 18, 2025, Operator requested a 30-day extension of its April 30, 2025, deadline. The District #2 Supervisor believes Operator's reasons for the request demonstrated good cause for an extension. Commission Staff grants Operator's request. Under the terms of the agreement, Operator's April 30, 2025, deadline is extended to May 30, 2025.
