### ORDER DENYING STAFF'S MOTION FOR SUMMARY JUDGMENT IN PART

Staff motions for summary judgment on one of the two remaining issues in these consolidated dockets: whether the Earl #1, Fecht D #1, and Watson #1 wells need to have casing integrity tests conducted upon them and/or be repaired or plugged.<sup>1</sup> Operator argues summary judgment is inappropriate. Upon review, the Commission finds limited upside in providing a detailed ruling analyzing the merits of Staff's motion and Operator's argument in opposition.

Staff's factual and legal allegations regarding K.A.R. 82-3-111(c) are not the entirety of what the Commission wishes to consider. The Commission solicits and intends to fully consider evidence regarding whether the status of the wells presents the threat of waste or violation of correlative rights, or a pollution threat to soils or waters of the state, necessitating casing integrity tests, repairs, plugging, or other action.

This matter appears headed for an evidentiary hearing, regardless, as the second remaining issue in these consolidated dockets is unresolved. So, in addition to the above, there is limited judicial

economy in granting Staff's motion. In short, the Commission believes it will be able to best rule upon the underlying, in-the-field issue presented in this case after receiving evidence from the parties at hearing. Accordingly, Staff's motion is denied.
