PROTEST TO APPLICATION FOR INJECTION WELLS PROTEST TO ISSUANCE OF PERMITS FOR FOUR INJECTION WELLS

Protestant, James D Howell Jr as Co-Trustee of the Nellie J Howell irrevocable Trust asks the KCC to deny the application for injection wells filed by Triple T Oil LLC and to deny permits to Triple T Oil LLC.

 Protestant is an interested party as a taxpayer on real property located within one-half mile of proposed injection wells.
The Trust address is 26789 Block Road Paola, Kansas 66071.

2. The protest is timely filed within 30 days of receipt of the Application by Triple T Oil LLC.

3. Protestant's interest is direct and substantial by virtue of Applicants activities polluting the grounwaters of Kansas which are the source of drinking water well and irrigation on Trust land. Further, those activities are in violation of correlative rights by an unfair taking of oil from a common source of supply and causing drainage from Trusts adjoining land. That the location of wells be determined from the property line with an allowable production determined by the Commission.

4. The Conservation Division is requested to take notice of Docket No. 15-CONS-456-CUIC (March 15, 2015 with the same parties and issues save Triple T Oil LLC has now moved south from Section 18 to Section 19 and within feet of protestants property line with increased pressure from 500 psi to 600 psi which brings with it increased risks.

5. The notice by Triple T Oil LLC was not in compliance with

the Statutes of Kansas by advising protester that no action was necessary and by a defective, incomplete Application which falsely stated under oath that documents were attached which in fact were not attached.

6. Triple T Oil LLC has not met its burden of proof that its drilling will not pollute the waters of Kansas by forcing fluids through permable rock strata that is free of fractures and into the water table.

7. It is now an established fact that pressurized injectibles into rock strata lubericates the cracks and causes movement which then allows pathways to the aquifer.

8. To grant the Application would be to sanction the violation of Protestors correlative rights by an unfair taking of oil from a common source of supply and to cause drainage from Trusts adjoining land.
