RE: Objection to the See Oil application for a permit to authorize the injection of saltwater into the Burge Lease, located in Crawford County, Kansas

Dear Mr. Stucky:

This letter is to serve as an objection to the See Oil application for a permit to authorize the injection of saltwater into the Burge Lease, located in Crawford County, Kansas and request a public hearing in the matter. This letter also contains a petition signed by residents of Crawford County Kansas and surrounding areas.

We object on the grounds that permitting the saltwater injection poses an immediate threat to usable, quality groundwater. We further object on the grounds that permitting the saltwater injection can cause an increase in seismic activity and poses an immediate danger to the health, safety, and welfare of the public.

First, we object because permitting the application for saltwater injection can pose an immediate threat to usable, quality groundwater. We are concerned about what other contaminants may be in the saltwater injections. We are also concerned about what efforts See Oil has taken to ensure the fluids injected into the rock formation will be isolated from the surround groundwater. We are requesting the Kansas Corporation Commission hold a public hearing in this matter to determine if denying the application for saltwater injection is necessary to protect fresh, usable water from pollution.

Second, we object because permitting the application for saltwater injection can cause an increase in seismic activity, which poses an immediate danger to the health, safety, and welfare of people in Crawford County. Crawford County has been experiencing an increase in seismic activity over the last several years. The consensus within the scientific community is that the recent increase in seismicity is generally related to increases in the disposal of saltwater produced along with oil and gas.

Restricting saltwater injection has been effective in other areas at reducing seismic activity. In Docket No. 15-CONS-770-CMSC, the Kansas Corporation Commission restricted saltwater injection rates in Harper and Sumner Counties due to an increase in seismic activity that posed an immediate danger to the health, safety, and welfare of public. Since the implementation of the order, seismic activity is trending downward in the area. While we understand the results are not conclusive, they are encouraging evidence that by continuing to restrict saltwater injection the Kansas Corporation Commission can further reduce the seismic activity that is endangering the public.


