MOTION TO RESCIND PENALTY ORDER

The Staff of the State Corporation Commission of the State of Kansas ("Staff" and "Commission," respectively) files this Motion, asking that the Commission's August 31, 2017, Penalty Order be rescinded. In support of its Motion, Staff states as follows:

- 1. On August 31, 2017, the Commission issued a Penalty Order against Norman H. Mills ("Operator"), due to an unplugged well remaining on his expired license. Operator's license had expired July 30, 2017, and Staff had sent a Notice of Violation letter August 1, 2017, giving Operator an August 15, 2017, deadline to obtain compliance to avoid a penalty. The Penalty Order was issued based upon Staff's August 18, 2017 penalty recommendation.
- 2. On October 2, 2017, Operator's Power of Attorney and daughter, Vickie Lukens, timely requested a hearing. Upon speaking to Ms. Lukens, Staff learned that Operator passed away on September 19, 2017. Ms. Lukens has since obtained a license herself (license no. 35544) and submitted a Transfer of Operator ("T-1") form, transferring the only well on Operator's license to her own.
- 3. While technically a violation of K.A.R. 82-3-120 occurred, given the circumstances Staff believes it would not be in the best interest of the state to pursue this matter, when Ms. Lukens has done everything necessary to remedy the violation.

WHEREFORE, Staff moves the Commission to rescind its August 31, 2017, Penalty

Order.
