Dear Ms. Thomas:

On behalf of Southern Pioneer Electric Company ("Southern Pioneer") and CMS Electric Cooperative, Inc. ("CMS Electric"), please find enclosed for filing the following:

Application to Cease Operation of Southern Pioneer for service territory located in Seward County, Kansas:

That area lying south of the existing CMS Electric Cooperative, Inc., three-phase line in the W ½ of the W ½ of Section 13, Township 35S, Range 34W; and

Application for Certificate of CMS Electric for territory located in Seward County, Kansas:

That area lying south of the existing CMS Electric Cooperative, Inc., three-phase line in the W ½ of the W ½ of Section 13, Township 35S, Range 34W.

The subject service territory, hereinafter referred to as "Service Territory" and as depicted in attached Exhibit A to the Application to Cease Operation and outlined in red, is located in a rural area and currently impacts no existing retail consumers of either utility. On February 21, 2014, via Docket 14-CMSE-395-CCS, CMS Electric made application to cease service to the Service Territory in order to more economically serve an unrelated single consumer located in Southern Pioneer's easterly Seward County service territory and Southern Pioneer, via Docket 14-SPEE-397-COC, made application for a certificate to serve the Service Territory as CMS did not have adequate facilities to eventually serve a proposed housing project. The Kansas Corporation Commission ("Commission") approved both applications, effective March 18, 2014. However, Southern Pioneer and CMS Electric have been advised that the project developer has now abandoned the

housing project development and sold the real estate to an individual, who desires to build a single residence and horse barn served at the single-phase voltage. CMS has facilities adjacent and immediately to the west of the Service Territory along Bird Road, where Southern Pioneer, if it was to provide electric service, would be required to 1) extend its electric facilities a considerable distance from the east to serve this sole consumer and 2) either obtain either private or public right-of-way easement(s), all at the consumer's expense pursuant to Southern Pioneer's Commission-approved line extension policy.

Therefore, the Southern Pioneer and CMS Electric Boards respectfully request with the filings of these Applications that the Commission approve the proposed territory exchange in order to economically serve the retail consumer.
