MOTION TO RESCIND ORDER DENYING APPLICATION FOR LICENSE

The Staff of the State Corporation Commission of the State of Kansas ("Staff" and "Commission," respectively) files this *Motion to Rescind Order Denying Application for License*. In support of its Motion, Staff states as follows:

- 1. On August 27, 2017, Operator submitted an application for license renewal.
- 2. On November 16, 2017, the Commission issued an Order Denying Application for License, based upon Staff's determination that the application did not meet the requirements of K.S.A. 55-155 and K.A.R. 82-3-120. Specifically, the application did not satisfy K.S.A. 55-155(c)(4) as available records demonstrated Operator was associated with John Pitman Estate, License #8704, which was an operator out of compliance with K.S.A. Chapter 55.
- 3. On November 28, 2017, Operator timely requested a hearing. The matter was set for a January 5, 2018, prehearing conference, subsequently continued to March 2, 2018.
- 4. Subsequent to January 5, 2018, John Pitman Estate, License #8704, was brought into compliance with Commission statutes and regulations. Accordingly, the underlying basis for denial of Operator's license has been resolved. Staff has concluded that Operator's application now meets the requirements of K.S.A. 55-155 and K.A.R. 82-3-120. Therefore, Staff requests the Commission rescind its November 16, 2017 Order Denying Application for License.

¹ Specifically, the Blasi #G-1, API #15-125-29002, an unplugged well remaining on John Pitman Estate's expired license, was plugged on January 25, 2018.

5. Should the Commission rescind its November 16, 2017 Order Denying

Application for License, all matters pertaining to Operator will be resolved, Staff will process the license renewal application, and this docket can be closed.

WHEREFORE, Staff respectfully moves the Commission rescind its November 16, 2017 Order Denying Application for License and close this docket.
